Non-Preemptive Rights Issue (NPRI)  
PT Impack Pratama Industri Tbk (Perseroan)**

Referring to the approval of the Company's Shareholders at the Extraordinary General Meeting of Shareholders ("EGMS") of PT Impack Pratama Industri Tbk. ("Company") on December 15, 2020 in the context of implementing NPRI and in compliance with the provisions of the Financial Services Authority Regulation No. 14/POJK.04/2019 concerning Amendments to Financial Services Authority Regulation No. 32/POJK.04/2015 concerning Increase of Public Company Capital by Granting Pre-emptive Rights (POJK No. 14/2019) and appointing our letter to the Financial Services Authority Number 69/IP-CORSEC/XI/2022 dated 7 November 2022 regarding Announcement of the Implementation of NPRI as well as our letter to PT Bursa Efek Indonesia Number 70/IP-CORSEC/XI/2022 dated November 7, 2022 regarding Application for Listing of NPRI Shares, we hereby convey the results of the implementation as follows:
