PT Impack Pratama Industri Tbk ("IMPC")**

UNTUK SEGERA DITERBITKAN/FOR IMMEDIATE RELEASE

Impack Pratama Pasang Panel Surya di 3 Lokasi Pabrik, Turunkan Emisi Karbon 4.783 MT per Tahun

Jakarta, 10 Februari 2022 – PT Impack Pratama Industri Tbk ("Perseroan") kode saham ("IMPC"), produsen bahan bangunan, bekerja sama dengan PT Surya Utama Nuansa (SUN Energy), akan melakukan pemasangan panel surya di pabrik lokasi Trembesi Delta Silicon 2, Lippo Cikarang, Jawa Barat, dengan kapasitas sampai dengan 4.473 KWp.

Instalasi panel surya di pabrik terbesar Perseroan ini, merupakan tahapan kedua dari program pengurangan emisi karbon yang telah dicanangkan Perseroan sejak tahun 2020. Sebelumnya Perseroan telah memasang instalasi panel surya di pabrik lokasi Hyundai, Lippo Cikarang dengan kapasitas 200 KWp. Tidak ketinggalan, distribution center baru Perseroan yang berlokasi di Surabaya akan dipasang panel surya pula dengan kapasitas 30 KWp.

Direktur Utama Perseroan Haryanto Tjiptodihardjo mengatakan, "Bilamana pemasangan panel surya di ketiga lokasi ini telah terlaksana seluruhnya, kami mengestimasi penurunan emisi CO₂ sampai 4.783 metric ton per tahun, seiring dengan penghematan biaya listrik sebesar Rp1,1 Miliar per tahun.

Pada kesempatan yang sama, Direktur Utama SUN Energy, Roy Wijaya, mengatakan "Sebagai pengembang proyek sistem tenaga surya nomer satu di Indonesia, SUN Energy menyambut baik kerjasama jangka panjang dengan PT Impack Pratama Industri Tbk untuk meningkatkan penggunaan porsi energi baru dan terbarukan di fasilitas operasional. Kami berharap, aksi nyata mengurangi dampak perubahan iklim ini secara khusus bisa diimplementasi oleh seluruh pelaku yang terlibat dalam rantai pasokan PT Impack Pratama Industri Tbk, serta menjadi contoh kepada para pelaku industri di berbagai sektor.

Perseroan senantiasa berkomitmen mewujudkan dan meningkatkan ESG *scoring* yang berkaitan dengan kegiatan bisnis Perseroan.

"Sebagai perusahaan manufaktur, tentu Perseroan perlu memikirkan dan berkontribusi dalam penurunan emisi karbon bagi lingkungan sekitar. Untuk itu, kami bertekad akan meneruskan upaya instalasi panel surya ini pada setiap fasilitas pabrik dan gudang distribusi kami yang akan datang", pungkas Haryanto.

Impack Pratama to Install Solar Panels on its 3 Plants, Carbon Emissions Decrease by 4.783 MT Annually

Jakarta, February 10, 2022 – PT Impack Pratama Industri Tbk ("the Company") stock code ("IMPC"), a building materials producer, collaborated with PT Surya Utama Nuansa (SUN Energy) to install a solar panel on its plant located on Trembesi, Delta Silicon 2, Lippo Cikarang, Jawa Barat, with a capacity of 4,473 KWp.

The solar panel installation on the Company's largest plant is the second stage of the carbon emission reduction program that has been launched by the Company since 2020. Previously, the Company has installed a solar panel on its other plant on Hyundai, Lippo Cikarang with a capacity of 200 KWp. Not to mention, the Company's new distribution center located in Surabaya will also be installed with a solar panel with a capacity of 30 KWp.

The Company's President Director, Haryanto Tjiptodihardjo said, "If the installation of solar panels on all three locations have been accomplished, we estimate a reduction of CO₂ emission by 4,783 metric tons annually, followed by electricity cost savings of IDR1.1 Billion annually.

At the same time, President Director of SUN Energy, Roy Wijaya, said "As the number one solar panel project developer in Indonesia, SUN Energy welcomes the long-term collaboration with PT Impack Pratama Industri Tbk to increase the use of new and renewable energy in operational facilities. We hope that this concrete action to reduce the impact of climate change in particular can be implemented by all parties involved in the supply chain of PT Impack Pratama Industri Tbk, as well as being an example to other industry players in various sectors.

The Company is always committed to realizing and improving the ESG *scoring* that is relevant to the Company's business activity.

"As a manufacturing company, it goes without saying that the Company is required to think ahead and contribute to reducing carbon emissions in the environment. For that reason, we are determined to continue our efforts to install solar panels on each of our manufacturing facilities and distribution warehouses in the future," concluded Haryanto.

Besides the commitment to the carbon emissions reductions, the Company has consistently carried
